Asset-to-Owner Connection

The money is typically kept aside for a length of time determined by law when institutions holding unclaimed assets have made attempts to contact the rightful owners but have been unsuccessful. If no one steps forward to make a claim for the money before the deadline, the entity either moves the money to another location or absorbs it, and any remaining claims for the money are nullified. Contingency - Fee Services
